Vermont Rails Show

November 18, 2017

The Northwestern Vermont Model Railroad Association is pleased to sponsor its second annual model train show in Central Vermont, to be held on Saturday, November 18, 2017, at the Barre Civic Center Auditorium in Barre, Vermont. The Barre Auditorium is easily accessible from exit 7 of Interstate 89. The Vermont Rails Show will include numerous exhibits of model trains, operating layouts, railroadiana, and dealers offering many types of model and railroad items for sale. Over 75 exhibitor tables will be available. Admission to the show will be \$5.00 for adults, \$1.00 for children 6-12 years of age, and children under 6 are free. The facility is handicap accessible, and the Berlin Volunteer Fire Department will be our food vendor this year, providing hot dogs and sandwiches, etc. The doors will be open to the public from 10:00 a.m. to 4:00 p.m.

All commercial tables are 8 feet long, and cost \$30.00 for the first table and \$25.00 for each additional table for reservations postmarked before October 1, 2017, or \$35.00 each for all tables after the cutoff date. **For exhibitors with their own free-standing display stands, we offer additional 8-foot spaces without a table at \$20.00 each for early registrations only. However, free-standing displays must be confined to the 8-foot spaces paid for!** Exhibit tables for railroad-related non-profit organizations are available at no charge. However, sales from exhibit tables are strictly prohibited. Please indicate if you prefer an outside wall, but recognize that many exhibitors share this preference, so we cannot always satisfy all requests. We will try to honor location requests, but we reserve the option to rearrange the room to best suit the traffic flow around the mix of layouts and exhibitor tables. Reservations and location requests are accepted in order of receipt.

To reserve space, please complete and return the attached reservation form. Commercial table reservations must include a check or money order made payable to: "NWV Model RR Association". Requests for cancellation refunds must be received by September 31, 2017.

Conditions for Dealers and Exhibitors:

- 1.) The State of Vermont requires that all commercial dealers have a Vermont Sales Tax Number, which **MUST** be included on the reservation form for tables. If you do not have a number, please apply through the Vermont Department of Taxes website at: tax.vermont.gov. If you qualify as a "casual seller," only selling used items from your personal collection, then a sales tax number is not required.
- 2.) Dealers and Exhibitors may begin setting up at 7:00 a.m. on the morning of the show. Setup time is available on Friday evening **5:00 – 8:00 p.m., no early exceptions.**
- 3.) Plan to complete unloading by 9:30 a.m., and remain set up until the 4:00 p.m. closing.
- 4.) Bring your own extension cords. Electricity is available at no charge.
